

Parties to the MSA

- **The States.** Signatories to the MSA include the 46 States, the District of Columbia, and the 5 Territories of American Samoa, Guam, Northern Mariana Islands, Commonwealth of Puerto Rico, and The Virgin Islands of the United States.
- **Original Participating Manufacturers.** The OPMs are the original companies that were the initial parties to the agreement signed November 1998. The OPMs are PM USA, Lorillard Tobacco Company, Brown & Williamson Tobacco Corporation and R.J. Reynolds Tobacco Company. Brown & Williamson Tobacco Corporation and R.J. Reynolds merged in July 2004.
- **Subsequent Participating Manufacturers.** The SPMs are the other tobacco companies who later agreed to sign the MSA and be bound by its provisions. To date, over 40 have.

Information on how to join the MSA and an application to do so can be found at www.naag.org. Tobacco companies choosing not to be parties to the MSA and therefore not bound by its provisions are considered Non-Participating Manufacturers or NPMs.

Participating Company Obligations

Companies that are parties to, and hence agree to be bound by, the MSA are required to:

- **Provide annual financial payments to the states in perpetuity.** These payments extend in perpetuity beyond the approximately \$45 billion in payments already made by the OPMs and SPMs through May 2007. In addition, the OPMs made initial up-front payments to the MSA states totaling over \$10 billion and an endowment to the American Legacy Foundation (in addition to OPM payments

of over \$1 billion to underwrite a national campaign by ALF that includes advertising and education programs). These payments are in addition to the approximately \$16.4 billion paid by the OPMs to the four previously settled states through 2007.

- **Limit lobbying activities.** The MSA prohibits tobacco companies from opposing specified state or local measures intended to reduce youth access to and consumption of tobacco products.
- **Publicly disclose documents through website.** The MSA mandates that the OPMs make vast numbers of internal industry documents easily available to the public. These OPM documents are available at www.tobaccodocuments.org.
- **Prohibit agreements to suppress research.** The Participating Manufacturers are prohibited from entering into any agreement "with any other Tobacco Product Manufacturer that has the purpose or effect of: (1) limiting competition in the production or distribution of information about health hazards or other consequences of the use of their products; (2) limiting or suppressing research into smoking and health; or (3) limiting or suppressing research into the marketing or development of new products." --MSA Section III(q)
- **Prohibit material misrepresentations.** The MSA prohibits Participating Manufacturers from making "any material misrepresentation of fact regarding the health consequences of using any Tobacco Product, including any tobacco additives, filters, paper or other ingredients." --MSA Section III(r)
- **Fund public education initiatives.** In addition to the youth smoking prevention efforts described in part below and other provisions, the MSA required each OPM to endow The American Legacy Foundation (ALF). In addition, the Participating Manufacturers were required to make payments of over \$1 billion to underwrite a national campaign by ALF that includes advertising and education programs.

- **Commit to youth smoking prevention efforts.**

Among other things, the MSA forbids Participating Manufacturers from targeting youth in the advertising, marketing and promotion of tobacco products; and from actions primarily aimed at initiating, maintaining or increasing youth smoking.

- **Adhere to specified marketing restrictions.**

These include, but are not limited to bans on: the use of cartoons in advertising, promotion, packaging or labeling of tobacco products; most forms of outdoor advertising, including billboards and stadium signs; and advertising in the form of the distribution of apparel or merchandise, such as caps, shirts and backpacks, bearing tobacco brand names and logos.

What The States Do

The states and territories that are signatories to the MSA:

- **Release past and future claims on health-care costs.** In addition to settling the lawsuits that the states brought against the major manufacturers for, among other claims, health-

care cost recovery, the MSA gives Participating Manufacturers and their distributors a broad release from certain future claims, including “statutory” liabilities, “for reimbursement of health care costs allegedly associated with the use of or exposure to Tobacco Products.” --MSA Sections XII(a)(1), II(n), II (nn)(2), II (oo)

- **Have the option of enacting Model Escrow legislation.** The MSA states have the option to enact model legislation to address Non-Participating Manufacturers (Exhibit T of the MSA). The MSA payment of states that do enact and “diligently enforce” the Model Escrow Statute in a given year will not be subject to an NPM Adjustment for that year.

The substantive provisions of the MSA are complex and broad in scope. *This is not a complete list of state or participating party obligations.* The summary is not intended to cover everything and is not intended to alter, interpret or supersede any of the terms of the agreement. **To view the MSA in its entirety, please visit www.naag.org.**

EXHIBIT F

POTENTIAL LEGISLATION NOT TO BE OPPOSED

Limitations on Youth access to vending machines.

Inclusion of cigars within the definition of tobacco products.

Enhancement of enforcement efforts to identify and prosecute violations of laws prohibiting retail sales to Youth.

Encouraging or supporting use of technology to increase effectiveness of age-of-purchase laws, such as, without limitation, the use of programmable scanners, scanners to read drivers' licenses, or use of other age/ID data banks.

Limitations on promotional programs for non-tobacco goods using tobacco products as prizes or give-aways.

Enforcement of access restrictions through penalties on Youth for possession or use.

Limitations on tobacco product advertising in or on school facilities, or wearing of tobacco logo merchandise in or on school property.

Limitations on non-tobacco products which are designed to look like tobacco products, such as bubble gum cigars, candy cigarettes, etc.
